1. **FROM NEWARK AIRPORT**

FOLLOW SIGNS FOR AIRPORT EXIT. TAKE NEW JERSEY TURNPIKE **SOUTH** TO GARDEN STATE PARKWAY **EXIT 11**. TAKE THE GARDEN STATE PARKWAY **NORTH** TO **EXIT 131**. **DO NOT TAKE EXIT MARKED A OR B**. AS YOU COME AROUND THE EXIT RAMP STAY TO THE RIGHT, THIS WILL PUT YOU ONTO ROUTE 27 **SOUTH**. AT THE 2ND TRAFFIC LIGHT, TURN **RIGHT** (WOOD AVE). GO TO FIRST TRAFFIC LIGHT, TURN **LEFT** (OAK TREE RD.). GO TO 5TH TRAFFIC LIGHT, TURN **LEFT** (PARK AVE.). GO ABOUT 1 MILE, HORIBA JOBIN YVON, INC. IS ON THE **RIGHT**.

2. **FROM NEW JERSEY TURNPIKE NORTH OR SOUTH**

TAKE NEW JERSEY TURNPIKE TO **EXIT 11** AND FOLLOW THE DIRECTIONS IN # 1.

3. **FROM ROUTE 1 NORTH OR SOUTH**

TAKE METUCHEN EXIT OFF ROUTE 1 (MAIN STREET/ROUTE 531). TAKE MAIN STREET/ROUTE 531 FOR ABOUT 2 MILES. TO PLAINFIELD AVE., TURN **LEFT** AT NEXT TRAFFIC LIGHT, TURN **RIGHT**. PLAINFIELD AVE. WILL CHANGE INTO PLAINFIELD ROAD. NEXT TRAFFIC LIGHT TURN **LEFT** (PARK AVENUE). AT NEXT TRAFFIC LIGHT, TURN **RIGHT** YOU ARE STILL ON PARK AVE. GO 3 TENTHS OF A MILE. HORIBA JOBIN YVON, INC. IS ON THE **LEFT**.

4. **FROM ROUTE 287 NORTH**

TAKE ROUTE 287 **NORTH** TO **EXIT 2A** METUCHEN ROUTE 27 **NORTH**. FIRST TRAFFIC LIGHT TURN **LEFT** (BRIDGE ST.) **MAKE A SHARP RIGHT IMMEDIATELY AFTER CROSSING RAILROAD BRIDGE**. NEXT LIGHT TURN **LEFT**, (CENTRAL AVE). AT THIRD LIGHT TURN **LEFT**, (PARK AVE). AT NEXT TRAFFIC LIGHT, TURN **RIGHT**, YOU ARE STILL ON PARK AVE. GO 3 TENTHS OF A MILE. HORIBA JOBIN YVON, INC. IS ON THE **LEFT**.

5. **FROM ROUTE 287 SOUTH**

TAKE ROUTE 287 **SOUTH** TO **EXIT 3** METUCHEN (NEW DURHAM RD/COUNTY ROAD 501). TURN **RIGHT** ONTO DURHAM ROAD. AT NEXT LIGHT TURN **RIGHT**. AT THE SECOND TRAFFIC LIGHT (1 MILE 8 TENTHS) TURN **LEFT**. GO 3 TENTHS OF MILE. HORIBA JOBIN YVON, INC. IS ON THE **LEFT**.

6. **FROM GARDEN STATE PARKWAY NORTH**

TAKE PARKWAY **NORTH** TO **EXIT 131**. **DO NOT TAKE A OR B JUST 131**. AS YOU COME AROUND THE EXIT RAMP STAY **RIGHT**, (ROUTE 27 SOUTH). AT THE 2ND TRAFFIC LIGHT TURN **RIGHT** (WOOD AVE). NEXT LIGHT TURN **LEFT** (OAK TREE RD). GO TO 5TH TRAFFIC LIGHT, TURN **LEFT** (PARK AVE.). GO ABOUT 1 MILE. HORIBA JOBIN YVON, INC. IS ON THE **RIGHT**.

7. **FROM GARDEN STATE PARKWAY SOUTH**

TAKE PARKWAY **SOUTH** TO **EXIT 131**. AS YOU COME AROUND THE EXIT RAMP STAY **RIGHT**, TO ROUTE 27 **SOUTH**. AT FIRST TRAFFIC LIGHT TURN **RIGHT** (WOOD AVE). NEXT TRAFFIC LIGHT TURN **LEFT** (OAK TREE RD.) GO TO 5TH TRAFFIC LIGHT TURN **LEFT** (PARK AVE). GO ABOUT 1 MILE. JOBIN YVON, INC. IS ON THE **RIGHT**.

8. **FROM LAGUARDIA AIRPORT**

COMING OUT OF AIRPORT, TAKE GRAND CENTRAL PARKWAY **WEST** (TOWARDS MANHATTAN). GO OVER THE TRIBORO BRIDGE TO MAJOR DEEGAN EXPRESSWAY. JUST AFTER YANKEE STADIUM, TAKE EXIT FOR GEORGE WASHINGTON BRIDGE. GO OVER GEORGE WASHINGTON BRIDGE TO NEW JERSEY TURNPIKE **SOUTH**. FOLLOW THE DIRECTIONS IN # 1.

9. **FROM JFK AIRPORT**

WHEN LEAVING AIRPORT, TAKE BELT PARKWAY **WEST** TO VERRAZANO BRIDGE. CROSS BRIDGE TO STATEN ISLAND (I 278 N) AND PROCEED TO GOETHEL'S BRIDGE, WHICH LEADS TO THE NEW JERSEY TURNPIKE **SOUTH**. THEN FOLLOW THE DIRECTIONS IN # 1.
